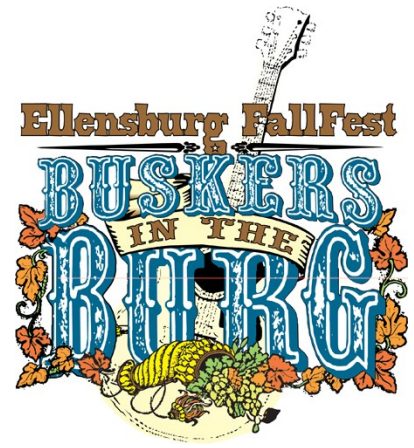


Buskers in the Burg Festival – Children’s Activities Waiver Saturday, September 28, 2013
